- Discussed updating, simplifying the application process. Changes discussed:
 - Change the required number of years of nursing experience as school nurse from 5 years to 2. Discussed, would like to keep it at 5 years
- Have the person making the nomination select 4 of the 6 areas of Nursing Practice to write a paragraph or two about the individual instead of all 6. All agreed
- Decrease the number of letters of recommendation from 6 to 3 or 4. Agree 3 references
